# 摘要

英國皇家保險學院(The Chartered Insurance Institute; CII) 於本(111)年 6 月 16 日以 視訊連線方式辦理 International Affiliated Institute Forum meeting,本中心由教育訓練 處王其盈專員及國際事務處陳專員喬琳出席。

本次會議邀請超過 30 間保險相關機構出席會議,並橫跨歐美、亞洲及非洲等地區,會議依照區域性分成兩個場次;中南亞及亞太地區及歐美非地區,議程包含專題講座及討論,本中心參與場次為中南亞及亞太地區場次,此場次共有四個主題: CII 之「共同創造未來」徵詢結果(CII Consultation),市場發展趨勢一機會與挑戰之回顧(Developing Trends),協助學習者進步之作為(Initiative)及共同合作以推廣 CII 之相關服務(Joint Marketing)。

本中心也積極與各國保險機構交流,針對保險知識持續推展,也呼應本中心扮演區域性保險智庫的角色。

## 壹、 會議目的及過程

英國皇家保險學院(CII)為一個金融保險服務專業機構,致力於保險和財務規劃 行業建立公眾信任。本年度會議因受疫情影響持續以線上視訊方式舉辦,與會人員來 自 CII 亞洲聯盟組織夥伴,包含中亞、南亞及亞太地區。

主辦方CII於會中談及今年發展主軸,並說明CII隨著近年全球疫情調整課程內容,提供與時俱進之課程主題,協助會員迅速掌握全球脈動,並期待與各聯盟組織夥伴合作,規劃實體以及線上遠距課程。

## 貳、 重要會議議程及內容重點

## 一、 CII 宗旨

CII 課程能滿足每一位 CII 會員於學術或工作領域之需求,透過課程專業認證得 與其職涯發展相互連結。

## 二、CII 課程規劃目標

## A. 簡化資格認證

CII 認證機制深獲不同域與年齡層參與者支持,依據統計資料,平均每 10 位英國 參與者中有 7 人認同;平均每 10 位國際參與者中有 9 人支持。CII 提供靈活多樣 之課程,課程內容兼顧理論與實務,參與者能就工作相關領域選擇相關學習課 程。

## B.CII 課程優勢

CII 提供靈活多樣之課程,其資格認證課程設計由簡入深,並依據各國保險市場實務經驗調整課程內容以接軌全球保險發展趨勢,同時滿足不同會員需求。

## C. 會員資格

CII 考量每一位會員工作經驗不同,提供客觀的認證機制,協助會員折抵部分學分,以期會員迅速尋求適當課程並取得國際認可證書資格。

## 三、CII 與國際保險機構之合作策略

## (一) 長期提供保險專業課程

- (二) 協助聯盟組織夥伴推動國際保險課程 CII 雖人員編制有限,但藉由與全球各地保險訓練中心合作,得以提供在地 化保險服務,長期推廣實體或遠距線上課程;CII 另可針對不同企業需求提 供線上遠距或實體培訓課程。
- (三) CII 課程採學分制度,能補足不同國家現行學程制度與國際認證課程間之差異,提供更具專業且實用之課程規劃。

## 四、本中心分享保險資訊及保險教育訓練課程

- (一) 本中心除了提供實體課程外,也建立完善的遠距線上課程,講師及與會學 員也比疫情前更加適應以遠距線上課程方式,整體遠距線上課程品質也有顯 著提升。
- (二) 近年來,台灣保險業市場趨勢包含科技技術應用、ESG等面向,而主管機關也十分關注高齡金融消費者保護等議題,另外,因本中心也扮演區域性保險智庫的角色,國際保險議題也是本中心關注焦點,如接軌 IFRS 17,故本中心也以研討會形式辦理專題講座,講師群除國內講師外,經常性邀請國外專家學者分享交流。
- (三) 本中心也開辦保險業務員必修課程,為落實保險業務員在職進修,以提升業務員素質並強化業務員對相關法令遵循,本中心負責數位課程之錄製,建立學習平台。

## 肆、心得與照片

藉由本次國際視訊會議,除更了解主辦單位 CII 與其他與會機構教育訓練課程主軸與模式外,中心兩位參會同仁也於會中表達台灣保險業目前著重於金融科技、資安議題、ESG、高齡弱勢金融保護與業務員 6H 教育訓練等議題,期待未來有機會與國際保險發展機構相互合作,共同辦理國際研討會或其他教育訓練課程,互利互惠,俾利台灣保險從業人員獲取更完善的保險知識。

除此之外,本次會議時長僅只有一小時,但於會議中安排開放性討論,達到充分意見交流及資訊互換,建議未來本中心辦理會議能夠增加討論時間,及在參加國際研討會中,多加利用機會分享保險資訊,強化國際能見度。
